- Print clearly.
- Only 1 registrant per form.
- Include preferred name to be printed on badge (if desired).
- Provide unique email address (used for confirmation and event app).
- Provide cell phone number (used for onsite updates).
- Select your registration fee – write amount in Total column.
- One Day Only – be sure to select day(s).
- Expo Only – valid for all three days.

### Optional Event Admission

- Be sure to register for all events you are attending.
- Your registration badge will be required for admittance to the Welcome Party Sunday evening.
- If Tuesday Funeral Directors Under 40, Wednesday Lunch and/or Oktoberfest at Snowbird tickets are purchased, you will receive those tickets with your badge.

### What's Included With Registration Fee?
